SAFETY PROGRAM PRE-EMPLOYMENT AGREEMENT

It is Raynor Company Group's objective to provide a safe and healthful work place for all employees.

To accomplish this, we have trained our field management personnel in the recognition, avoidance and prevention of accident causing conditions and/or acts of employees that may cause injury or death to employees and subcontractor employees.

Each employee has a responsibility to contribute to the overall safety.

The following rules and regulations are minimum standards and must be obeyed.

1. **Report all injuries immediately, no matter how minor, to your direct supervisor. He will direct you for proper treatment and recording. For all injuries requiring medical attention, the employee must immediately report to the job specific clinic set up for that job and submit to drug screening.**
2. Report any unsafe conditions to your supervisor including defective equipment.
3. Obey all safety and warning signs. Always be conscious of the safety of yourself as well as others around you. Foreman on the projects are to make sure all safety measures are taken.
4. Keep your area free from rubbish and debris. A clean job is a safe job.
5. Hard hats, safety belts, goggles, safety toe shoes, masks and other types of personal protections equipment, determined by work being done, must be worn and maintained in good condition.
6. Shirts and long pants must be worn to prevent sunburn and to protect against acid burns, steam burns, weld splatter and cuts.
7. Firearms of any kind are not to be brought to the job site.
8. Raynor Company Group employees are not to play radios on the job. It can interfere with instructions or danger warnings and also aggravate others who may not like your choice of music or programs.
9. Do not operate tools until properly trained in use and authorized to operate. Be sure all Point-Of-Operation power transmissions and revolving parts are shielded. Be especially mindful when working around the mixers.
10. Lifting – Learn to lift properly. Know the seven basic steps of lifting. If you need help as for it.
11. Movement – Walk, never run. Use handrails on stairs. Be cautious when approaching swinging doors, corners, congested areas, etc.
12. Never move an injured person unless absolutely necessary.
13. Horseplay – Horseplay and rough-housing is prohibited.

14. Personal Hygiene – Be fit for the job, through good health, habits, proper meals and sufficient rest.
15. Controlled or illegal substances or alcohol will not be permitted on the job site.
16. Be alert for fires and know where fire fighting equipment is located.
17. Riding material hoisting equipment is prohibited.
18. Know and follow OSHA rules and regulations.

Each job site superintendent or other designated person will be responsible for the following:

- Monitor all personnel and equipment for safety on regular basis.
- Conduct weekly safety meetings with all job site personnel.
- Provide full cooperation during OSHA inspections.
- Complete all accident reports or transmit accident information to the office immediately.

Warehouse Personnel are responsible for:

- Determine that all tools and equipment are in safe working order to being sent to any job site.
- To have fully stocked first aid kits available for all job sites.

Any employee who deliberately and intentionally violates company safety and/or OSHA regulations will be subject to disciplinary action as follows:

- 1st infraction of above rules – 1-day suspension without pay
- 2nd infraction of above rules – 1-week suspension without pay
- 3rd infraction of above rules – TERMINATION OF EMPLOYMENT

Form W-4 (2017)

Purpose. Complete Form W-4 so that your employer can withhold the correct federal income tax from your pay. Consider completing a new Form W-4 each year and when your personal or financial situation changes.

Exemption from withholding. If you are exempt, complete only lines 1, 2, 3, 4, and 7 and sign the form to validate it. Your exemption for 2017 expires February 15, 2018. See Pub. 505, Tax Withholding and Estimated Tax.

Note: If another person can claim you as a dependent on his or her tax return, you can't claim exemption from withholding if your total income exceeds \$1,050 and includes more than \$350 of unearned income (for example, interest and dividends).

Exceptions. An employee may be able to claim exemption from withholding even if the employee is a dependent, if the employee:

- Is age 65 or older,
- Is blind, or
- Will claim adjustments to income; tax credits; or itemized deductions, on his or her tax return.

The exceptions don't apply to supplemental wages greater than \$1,000,000.

Basic instructions. If you aren't exempt, complete the **Personal Allowances Worksheet** below. The worksheets on page 2 further adjust your withholding allowances based on itemized deductions, certain credits, adjustments to income, or two-earners/multiple jobs situations.

Complete all worksheets that apply. However, you may claim fewer (or zero) allowances. For regular wages, withholding must be based on allowances you claimed and may not be a flat amount or percentage of wages.

Head of household. Generally, you can claim head of household filing status on your tax return only if you are unmarried and pay more than 50% of the costs of keeping up a home for yourself and your dependent(s) or other qualifying individuals. See Pub. 501, Exemptions, Standard Deduction, and Filing Information, for information.

Tax credits. You can take projected tax credits into account in figuring your allowable number of withholding allowances. Credits for child or dependent care expenses and the child tax credit may be claimed using the **Personal Allowances Worksheet** below. See Pub. 505 for information on converting your other credits into withholding allowances.

Nonwage income. If you have a large amount of nonwage income, such as interest or dividends, consider making estimated tax payments using Form 1040-ES, Estimated Tax for Individuals. Otherwise, you may owe additional tax. If you have pension or annuity income, see Pub. 505 to find out if you should adjust your withholding on Form W-4 or W-4P.

Two earners or multiple jobs. If you have a working spouse or more than one job, figure the total number of allowances you are entitled to claim on all jobs using worksheets from only one Form W-4. Your withholding usually will be most accurate when all allowances are claimed on the Form W-4 for the highest paying job and zero allowances are claimed on the others. See Pub. 505 for details.
